#### **Access**

All documented Access reports are summarized by whether they were screened in or out, Alternative or Traditional Response, and Service or CPS Reports. The Access history is also detailed within a table. Some Access reports will appear on multiple rows as the report displays one row per allegation, per alleged victim, and per alleged maltreater relationship. If the case has multiple Access reports, the report differentiates the reports by color. The county of the Access report is noted to be the county assigned to the Access screening supervisor. The report date and response time is also provided.

#### **Initial Assessment**

All documented I.A.s are summarized by whether they were Alternative or Traditional Response, substantiated or services needed, and safe or unsafe. The detailed lists of Initial Assessments are likewise organized to provide one row per allegation, per alleged victim, and per alleged maltreater. Color blocks denote different Initial Assessments. The table also states the IA approval date, county, allegation finding, alleged maltreater allegation finding, and safety decision. Also provided are the I.A. Disposition and 'Family Characteristics' from the most-recent completed I.A.

#### **Case History**

Summary information of the case history includes the date the case was first opened and most recently opened. The information provided on a participant's documented disabilities or documented AODA issues is taken from the individual's 'Characteristics' page of eWiSACWIS. The number of child participants is determined by date of birth; if DOB is unavailable, an individual will not be identified as a child. The 'current participants under county responsibility' are the case participants who have the 'Rsp' flag checked within the list of active participants. Likewise, the 'current household members' are the active case participants who have the 'Hshld' flag checked.
